Motion was seconded by Saundra Mies-29 Grantham. Motion carried 4-0. 30 Discussion and 31 Information Items: 32 **Emergency Water** 33 Line Repair: The District Staff responded to a report of a leak on the intersection of Oceania Drive and 34 Bridgeview in Bayshore Subdivision on Dec 31. It took all day to fix the leak. The water 35 line was buried in 20 feet of sand. It was apparent that the pipe was unable to support the 36 weight of the sand and sustained a stress fracture causing the pipe to break. Property owners are dumping sand from their properties to the easement adding weight on top of 37 38 the water line. There have been four line breaks in Oceania Drive in one year. The entire 39 community needs to be aware of the danger of piling sand on top of the water line. The 40 General Manager is working with Lincoln County/Bill Hall and discussing the importance of having a Sand District. The County has jurisdiction authority to site those who pile sand 41 on the right of way. The long term solution is to form a Sand Removal District. If this 42 43 happens the District will share in the one-time cost for removing the sand. Another 44 solution is to replace the 1,800 linear feet of pipe in Oceania Drive with HDPE pipe for 45 about \$250,000. The County has jurisdiction to make sure the right-of-way is free of 46 debris. But proof by pictures or videos are needed before they can site the property owner. SRWD has no authority to move the sand off where the water line is located. 47 The District had to hire a contractor with necessary equipment needed to help fix the leak 48 49 that was 20 feet under the sand. 50 Hwy 101 Leak: There was a major leak on Feb 9. The 12" water main line on Highway 101 by the 51 entrance of the ODOT Maintenance Facility was hit by the boring contractor as they bore 52 across the road from Huckleberry to the ODOT entrance location. This main line feeds the 53 54 55 56 143rd St. Leak: 57

south of the system. The staff was able to isolate the leak quickly so no one was out of water. Locate was about 4 feet off from the pipe. The contractor failed to pot hole as the contract specified. The importance to pot hole was talked about several times during the weekly meeting. This is a learning experience for SRWD staff and the contractor. On Feb 9 staff responded at 11 pm to a report of running water at 143rd St. Utilities needed to be located so staff put a temporary patch until the following day. This area has had several leaks in one year. Several years ago the area was filled with fill materials and was not compacted. The fill material is settling where the line keeps breaking. Staff is exploring options that might allow for replacement of the water line sooner if possible. The engineer estimated it will cost \$200,000 to replace the pipe at 143rd.

63 64 The District received 4 SOQs and were reviewed by the panel approved by the Board. Engineer of Record: 65 The two top engineering consultant firms were interviewed. The General Manager created 66 a point summary of scoring from the review panel. The results were - Civil West 602 67 points and CH2M Hill 601 points. The overall percentage was 86% for Civil West and 85.85% for CH2M Hill. The Board needed to vote for a resolution. An appearance of 68 conflict was discussed due to a long time relationship of one of the commissioners with an 69 70 engineering firm due to past employment. It was motioned by Saundra Mies-Grantham to 71 approve Resolution No. 0216-01, A resolution authorizing Seal Rock Water District to 72 negotiate and enter into agreement for engineering consulting services and delegating 73 authority to the General Manager to sign the agreement. Motion was seconded by Rob 74 Mills. John Garcia voted Yes, Saundra Mies-Grantham voted Yes, Rob Mills voted Yes 75 and John Filbert declared a conflict and abstained from voting. Motion carried 3-0. 76 Reports, Comments, 77 and Correspondence: 78 Office Closure: The office will be closed on Monday, February 15 in observance of President's Day. 79 80 SDAO Annual 81 Conference: Rob Mills reported that the SDAO Conference on Feb 5-7, 2016 at Sunriver was a 82 success. There was a huge attendees and SDAO had to turn down some registrants. 83 SDAO employees made themselves available to members to answer any questions they 84 have. The classes were all well attended. The rewards banquet was excellent. It showed 85 real sense of element of service, innovated and smart people who are serving in their own 86 agencies and communities and SDAO recognized them by giving awards to deserving 87 individuals and groups at the banquet. 88 Adam Denlinger reported that Rob Mills' class was packed with attendees. His 89 presentation was Board Practice Assessment (BPA) which is available online. It was very 90 beneficial for attendees who had the freedom to ask questions and have a conversation 91 regarding how BPA would help their agency. During the banquet Frank Stratton, SDAO 92 Manager mentioned that Special Districts is the fastest growing agency in the country. 93 SDAO presentation materials are available online. 94 95 Water Quality: Staff will be inserting a community mailer with the bills this month.
