General Manager's Report:
 Board Meeting May 11, 2023

This report is an executive summary provided with this Board agenda to Commissioners with recommended actions if any. Detailed information, staff reports, and supporting materials are provided within the full agenda packet.

PHASE-IV BEAVER CREEK SOURCE WATER PROJECT:

Jacobs engineers continue tracking final punch list items necessary to certify final project completion. The contractor has been very slow in responding to punch list items. Preliminary Certification for Substantial Completion has been signed by the engineer and the district and presented to the contractor on January 18, 2023. As of the date of this letter, the engineer has not received a signature on substantial completion from the contractor.

On April 27, 2023, SRWD staff and engineers hosted a tour of the Water Treatment Facility for the Makai Community. Approximately 60 attendees visited the site and received an opportunity to see how water is treated from Beaver Creek through the ultra-membrane filtration process before making its way to the customer.

OREGON HEALTH AUTHORITY - WATER SYSTEM SURVEY:

A Water System Survey at Seal Rock Water District was performed by Oregon Health Authority on March 13, 2023. The main purpose of the survey was to evaluate the entire water system in terms of supplying safe drinking water to the public. The water system facilities were found to be well-operated and maintained by knowledgeable and competent staff. No significant deficiencies or rule violations were identified.

Drinking Water Services has established criteria for determining whether a system has demonstrated "outstanding performance." SRWD's water system met the criteria and has been designated an Outstanding Performer. Outstanding Performers may have the frequency of their water system surveys reduced from every three years to every five years. Therefore, our next water system survey will be scheduled in five years.
